Keeping in view circumstance and facts of the case, further proceeding by the Commission shall not only be an abuse of process, but also a futile exercise. Since the FIR was registered prior to registration of the case in the Commission, therefore the Investigation Agency may deal in accordance with law. The case stands disposed of.
